For Example A.E. Yuzwa E.G. 6 types of family upbringing have been identified in children with Eidemiller sensitivities and psychopathy.

Gipoprotektsiya (hypo) is characterized by the lack of the necessary care to the children ("children hands not to touch"). Feel to leave such a relationship with the child himself, as is almost left to his own devices.

Hyperprotection Dominant hyperactive child, intrusive with care to cover, completely blocking put his independence and initiative. Emotional rejection was manifested in rejection in all manifestations of the child. Rejection can manifest itself clearly (for example, a child often hears phrases from parents such as: "I'm tired of you, leave, don't go to me") and in the form of ridicule, irony and ridicule.

Cruel relationships they can manifest themselves clearly: in the form of beatings - or in a mask: in the form of emotional hostility and coldness. Increasing spiritual responsibility arises from the requirement that this child demonstrate high moral qualities with hope for a specific future. Parents with this type of Education entrust their child to the care and guardianship of other family members.

Improper upbringing can be considered as a reinforcing factor for the child's characteristic diseases. Under character stress is traditionally understood the excessive seriousness of individual characteristics and their combinations, which represent extreme variants of the norm. The accumulated signs are characterized by increased sensitivity to individual traumatic effects.
