Reform in Legal Education: The Nature of Analysis and Results

Abstract: This article provides a detailed analysis of the development of the national legal education system in the context of the conceptual reforms implemented in recent years at the Tashkent State Law University.

Today, a large-scale work is underway in our country to further reform the legal education system. In the context of the ongoing reforms, increasing the effectiveness of national legal education, training highly qualified lawyers, the development of legal science is a priority.

In this regard, it is worth noting the following reforms to further increase access to higher legal education by expanding the scope and scale of the Tashkent State Law University.

One of the important measures since the introduction of the credit-module system in the educational process of the university is the introduction of joint educational programs with foreign universities and the introduction of the electronic university system.

So far, the country has adopted more than 15 pieces of legislation on the organization of legal education and the introduction of a system of legal training.

Given that Tashkent State Law University is a basic higher education and scientific-methodological institution for the training and retraining of legal personnel in the field of "jurisprudence", it is possible to analyze the development trends of the national legal education system in our country.

Leadership in international rating systems. The concept of development of judicial bodies and institutions for 2020-2024 provided for the inclusion of Tashkent State Law University in the list of the best higher education institutions in the rankings of internationally recognized organizations, as well as ensuring its place in the national rankings.

As a result, in April of this year, the Times Higher Education, which covers important issues in the field of higher education in the UK and evaluates the performance of universities, announced the results of its next THE Impact Ranking.

In this ranking, Tashkent State Law University is the world It ranked 401st among thousands of participating universities from 94 regions and countries.

However, in September of this year, the Times Higher Education published a ranking of the world's leading universities. In other words, 450 educational institutions with reporter status are included in

this ranking, and Tashkent State Law University is in the top ten among higher education institutions of the Republic of Uzbekistan.

Joint educational programs in the field of study. This year, the Ministries of Justice and Higher and Secondary Special Education of the Republic of Uzbekistan have approved the parameters of admission to joint educational programs with the participation of the university for the 2021/2022 academic year.

A total of 280 Russian language students will be admitted to the joint educational programs, including MSG Narikbaev KAZGUU University, Grodno State University, Nizhny Novgorod State Research University named after N. Lobachevsky. students were admitted to abbreviated programs.

Street Law Project. Practical News. Street Law is a project aimed at teaching law students the most important legal knowledge in everyday life through interactive methods.

It should be noted that in August of this year, several talented students of the university had the opportunity to participate in the five-month program of the Central Asian Academy of Youth Leaders - a five-year program funded by the United States Agency for International Development (USAID) and implemented by the Eurasia Foundation.

Modern technologies in legal education. President of the Republic of Uzbekistan April 29, 2020 The Decree "On additional measures to radically improve legal education and science in the Republic of Uzbekistan" provides for the transition to electronic document exchange and digitization of the educational process, including the formation of schedules, examinations, assessments, student rankings. University) project.

Full implementation of this project at the university will allow to automate the educational and scientific process.

Currently, a center for the implementation of this project at the Tashkent State Law University has been established and appropriate measures are being taken to launch the system.

Internships at the University through the development of modern technologies and interactive teaching methods (E-Minbar electronic platform), independent learning and practical activities of students (case studies, coaching, etc.), as well as ensuring distance interaction between teacher and student (webinar technologies) The introduction of a modular, object-oriented and dynamic learning environment (Moodle) for the development of innovative and analytical thinking is planned, and practical work is being carried out at the university.

Also, by creating an effective system of "research and innovation center - department - production" with the help of the Research and Innovation Center of Tashkent State Law University, which allows to predict, identify and eliminate systemic problems of law enforcement, including the establishment of contacts between consumers of legal services. In order to implement the concept of "University 3.0", the innovative system "Foresight-forecasting" is gradually being introduced.

International cooperation in legal education. The university administration has taken practical measures to expand international cooperation through the introduction of double degree programs, sending doctoral students to foreign universities, as well as the involvement of leading foreign experts in educational and research activities at Tashkent State University of Law.

In particular, this year the National Forensic University of India, two prestigious higher education institutions of the Russian Federation - Altai State University and Kazan Federal University, Gdansk University of Poland, Kazakhstan University of International Private Partnership, Saratov State National Research University, Baku State University of Kyrgyzstan, Kyrgyzstan - A number of memorandums and agreements on expanding international cooperation in the field of legal

education with foreign educational institutions such as the Uzbek International University, Belarus State University are being signed and practical work is being done.

In addition, in August of this year, cooperation was established between the International Organization for the Development of Law (Rome) and TSU, which supports and promotes the rule of law, promoting the implementation of legal reforms in countries.

The main purpose of this cooperation is to hold roundtables on joint projects, research, development of commercial mediation, organization of internships for students.

During this time, partnerships were established with the University of Rome in Rome, Italy to organize internships for researchers, conduct joint research and conduct classes for professors of the University of Rome Tre TSU, joint summer schools and special trainings for professionals.

In addition, a memorandum of understanding was signed with the International Institute for the Unification of Private Law, an international intergovernmental organization that prepares international documents in the field of private law.

In conclusion, it should be noted that on the basis of these reforms, the further development of national legal education through the introduction of advanced foreign experience, in turn, will contribute to the training of personnel with modern ideas and knowledge, improvement of jurisprudence and legal sciences.
