

The Formation of Complicated Sentence in English Language

Reading is considered to be one of the paramount and inseparable parts of learning the language. That aside, not only foreign language learners but also native speakers pay special attention to this field. Specifically, English language learners and native speakers put as much effort as they can in order to be master in it. The most significant reason the structure and vocabulary of the language are peculiar compared to other languages. As a consequence of learners and young native speakers come across some difficulties. Mostly, these issues are concerned with comprehending the intended meaning of the written information. Feeling difficulty in understanding becomes a common problem even for brilliant students. Despite of knowing all words they could not analyze particular utterances. These utterances are called complicated sentences in linguistic. Complicated sentences are observed by many linguists but nobody studies it as an integral field. To say it differently they just provide their point of view in their books which are devoted to grammar, word formation, and structure. A case in point, Schlesinger, Barmouth, Pearson, Recheck, Chomsky, Ray Jackendoff. They observed complicated sentences but not profoundly. It must emphasize that, due to the lack of information and assimilate properties some linguists consider the complicated sentence and complex sentence as a synonym. However, most linguists and native speakers claim that both mentioned notions are completely different, so considering them synonym is a rude mistake.

Main body.

These days, there are lots of misconceptions about complicated sentences. Due to abnormal properties, the thoughts of people about existing and using complicated utterances break up into two groups. Some part of people promotes utilizing complicated sentences while the other part of people obstructs it.

Transmitting information is an exceptionally important process in expressing a human's intended meaning. So, people are able to share it with a help of utterances whether it is in a written form or oral way. However, it should be stated that the utterances can be variable depending on where a person used them and when he or she used them. But some linguists claim that, sentences should be formed based on what we are going to talk about and whom we talk. Only taking into consideration

the aforementioned factors people can choose proper types of sentences during their oral or written way of discourse.

According to the structure, sentences are divided into the following: simple compound, complex, compound-complex. These sentences break up based on the number of clauses that they have. But it must be stated whereby complicated sentence. Unlike other types of sentences, complicated utterances encompass a good number of dates. In other words, complicated sentences' most remarkable property is including lots of details, arguments even complex notions. Complicated sentences are mostly utilized in scientific researches as well as in novels. Nowadays modern novel writers try to format short utterances in order to make them more comprehensible to readers however in the Middle Ages authors used sentences with different stages of difficulties. That aside old novels have ample long and complicated utterances [1].

A great number of linguists claim that forming complicated utterances is not an easy task specifically for foreign language learners. The most significant reason while creating a new sentence, students have to take into consideration all factors from proper word order to right choosing tense in it. Hence, teachers and instructors strongly recommend them use a few complicated sentences as possible. Aside from that, most of the coaches to be on the thought that before formulating any kind of complicated sentences students should follow some rules. Firstly, a researcher should understand the information which he or she wants to write. If he writes complicated sentences without any understanding, he would make a problematic sentence. There are three kinds of problematic sentences. The first is run-on sentence – in this kind of utterance a writer has not put any punctuation mark. As a result, the sentence became hardly understandable. The second is sentence fragments. These types of sentences are considered to be a common mistake in writing. This mistake occurs due to the lack of grammar knowledge. The third is a rambling sentence. The ramblingsentence is a type of utterance in which clauses connect with a help of coordinating conjunction. Take and, or, so as an example. Followingthe above-mentioned mistakes is so bad for the writer as it is a sign of a poor experience of a writer. For that reason, the foreign learner ought to deter using complicated sentences [2].

Many English native speakers observed the function and structure of complicated sentences. The main trigger of analyzing complicated sentences was children who faced difficulties while reading though they had an adequate vocabulary. That circumstance was immersing for linguists, that aside they devoted their time to observing sentence structure and grammar. Diversity of studies have found that grammatical complexity highlighted a reading problem for learners. Complex sentences are often characterized via utilizing anaphora, as referencing is demanded in order to encompass ideas in sentences. Their researches demonstrate that children have difficulty dealing with anaphora. Complicated sentence structure is thus known to cause reading difficulties for students [3].A complicated sentence is a complex sentence, parts which sometimes can be grammatically independent of each other, which means they might be equally related to each other. The main indicator is grammatical equivalence, a means of connecting parts into a single whole andthe compositional union is expressing semantic relation.

At the beginning of the 20th century, a structural and semantic approach to the study of a complex sentence, according to which among complex sentences differ between open and closed structure.

Complicated sentences of an open structure form an open row, consisting of two or more parts, the number of which can potentially be increased by adding new parts while closed structure sentences form a closed row, always consisting of two parts and not allowing further dissemination. Open structure complicated sentences are divided into two groups: 1) sentences expressing connecting relations; 2) sentences expressing separating relations.

In the first group of sentences, connective enumerative, connective-resultant, connective propagative, and other relations are expressed with the help of unions such as and, neither - nor, too, also.

By the nature of the temporal relationship between parts connecting sentences can express a relationship of simultaneity and the sequence of events. The relationship of simultaneity is expressed using the union and imperfective verbs, for example: At night it smelled bitterly smoldering foliage and the autumn stars were burning feverishly brightly, but in the morning a cold wind raged, leaving one dust in the air. Relation of subsequent is expressed in sentences in which predicate verbs have the form of the integral form or the fully formed and partially formed.

The complicated sentence is an area that was not fully discovered. But it does not mean that there is no research or information about this. Various studies and researches of writers are partially dedicated to this topic. Aside from that, information about complicated sentences appeared after the classification of sentences according to their structure. Until that time complicated sentences were considered compound or complex sentences. In fact, complicated sentences are long so that it was normal for them to consider it another type of sentence. Even these days not all language learners have the capability to differentiate complicated sentences from other sentences specifically from complex and compound sentences. Despite of having insufficient books and articles about complicated sentences English speakers are trying to explain them in a simple way. This all feedbacks and explanations exist with a help of advanced technology. In other words, a great number of English teachers provide various interesting information to any topic related to their own language. So, some of them create their own websites in which they send responses to language learners' questions. Having these websites substantially increased finding any information.

It must be emphasized that most language learners have a misconception about complex and complicated sentences. Some of them reckon that both mention notions are identical, however, it is not true. Complex specifically deals with how much while complicated concern how difficult might be a particular sentence.

A sentence could be both complex and complicated, and either might be roughly understood as a tax utterance. However, to be accurate the use of complex is particular to its level of detail – for that reason, if the plan is interpreted as difficult, it is since it has a lot of components. What we are intended to state is the utterance has many components, the word difficult is an interpretation of that. A complicated sentence, meanwhile, may be difficult because it has a lot of data, but it may also be difficult simply because it has not been explained properly. What we are saying with complicated is that it is difficult because it has many factors, but these facts are not necessarily due to having many parts. Aside from that, it could also be due to other factors such as external influences.

Complex and complicated arguments are another example. The two sentences below might be interpreted the same way as a difficult or entire argument, but the feedback in brackets shows a more precise interpretation.

- “He developed a complex plan.” (The plan had many different details, perhaps covering a lot of angles and considering different viewpoints.)
- “He developed a complicated plan.” (The plan had many different details that were perhaps hard to follow.)

The other reason for misconception is, both maintained notions meaning assimilate to each other. Hence, learners interpret it as a difficult utterance. Aside from that, most linguists observed only

complex sentences as a consequence of the information about the complicated sentence is inadequate [4;138]

Example of complicated sentences.

As maintained before complicated sentences might be long and they encompass a good number of details. The length of the complicated sentence depends on the information that the writer intended to express. The longest sentence in English is also fabulous. So, the longest sentence award goes to:

- Jonathan Coe's *The Rotter's Club*, embody 13,955 words sentence;
- And for a runner-up: James Joyce, *Ulysses*, encompass 4,390 words sentence [5].

There are some examples of complicated utterances in literature:

Vladimir Nabokov, "The Gift." 96 words.

"As he crossed toward the pharmacy at the corner he involuntarily turned his head because of a burst of light that had ricocheted from his temple, and saw, with that quick smile with which we greet a rainbow or a rose, a blindingly white parallelogram of the sky being unloaded from the van—a dresser with mirrors across which, as across a cinema screen, passed a flawlessly clear reflection of boughs sliding and swaying not arboreally, but with a human vacillation, produced by the nature of those who were carrying this sky, these boughs, this gliding facade."

Jose Saramago, "Blindness." 97 words.

"On offering to help the blind man, the man who then stole his car, had not, at that entire moment, had any evil intention, quite the contrary, what he did was nothing more than following those feelings of generosity and altruism which, as everyone knows, are the two best traits of human nature and to be found in much more hardened criminals than this one, a simple car-thief without any hope of enhancing in his profession, exploited by the real owners of this enterprise, for it is they who take benefits from the needs of the poor."

Vladimir Nabokov, "Lolita." 99 words.

"My very photogenic mother died in a freak accident (picnic, lightning) when I was four, and, save for a pocket of warmth in the darkest past, nothing of her subsists within the hollows and dells of memory, over which, if you can still tolerate my style (I am writing under observation), the sun of my infancy had set: surely, you all know those redolent remnants of day suspended, with the gnats, about some hedge in bloom or suddenly entered and traversed by the rambler, at the bottom of a hill, in the summer dusk; a furry warmth, golden midges."

From the aforementioned examples, we can realize that complicatedness and length of utterance rely on the writer's ability to choose words, horizon, knowledge towards vocabulary and grammar. Moreover, he or she must be gifted at forming sentences. It is exceptionally important because lacking these abilities not only might put the writer in troublesome circumstances but also it will cause misconception among readers. Because irrelevant details cannot create integral meaning in readers' minds.

Nowadays in linguistics, each notion has its function and rules which people follow. But not all fields are precisely depicted with rules or structure. Complicated utterances also encompass the field which needs profound investigation and entirely depicted rules. Complicated sentences it is the only type of sentence that can be difficult for students, due to having many details or facts in one sentence might cause a problem with understanding. Aside from that, forming proper complicated sentences is a type of task which not all people find easy. However, English language speakers still prefer using complicated sentences in their written information. In fact, a great number of research

writers tend to form complicated sentences in their papers. The main reason for using complicated sentences is to demonstrate their knowledge of the issue or topic observed. Moreover, with a help of complicated sentences author gets a chance to state information and factors just in one sentence, via this method they do not have to give extra explanation or definition. But it does not mean that writers all-time use complicated sentences consciously in order to show off their precious talent or ability. To state it differently, he frequently writer explain his thought with difficult notions and sentence structure however they are not intended to it. Actually, researchers and linguists learn as much information as they can. So, dealing with the difficult phenomenon and scientific way of explanation did not create any trouble for them. But meanwhile, this information might be really complex for learners because of their insufficient knowledge in a particular sphere.

Conclusion. People are not fond of using complicated sentences due to the fact that, including so many factors in one sentence is considered a problematic concept for them. Hence, they deter using complicated sentences by making a simple sentence. But it must be an advocate that, not all time we can use this method because frequently have to write some documents or brief information about to particular book or research in those maintained cases, we should write complicated sentences. That aside, we ought to know forming complicated utterances. However, many researchers think that all long sentences are might be complicated but it's a delusional point of view. As not all-time sentences encompass so many details that students find it complex to analyze. So, in order to be master in forming a complicated sentence and understand their intended meaning student should follow some methods.
